PUBLIC ADVISORY

In view of the India Meteorological Department (IMD) warning and incessant rainfall over the past two days in Cachar District, it is observed that the water level of River Barak is rising steadily. As a result, there is an increased risk of flood like situation in Cachar District and urban flooding in low-lying areas of Silchar City due to continued rainfall.

The District Disaster Management Authority (DDMA), Cachar advises the general public to take the following precautionary measures:

1. Avoid unnecessary movement in low-lying and water-logged areas of Silchar, especially during heavy rain.
2. Keep electrical appliances switched off and valuables at elevated places to avoid damage in case of water ingress.
3. Citizens residing in flood-prone urban pockets are advised to remain alert and prepared for possible waterlogging or evacuation if required.
4. Do not attempt to drive or walk through flooded streets to avoid accidents or getting stranded.
5. Keep emergency kits, dry food, drinking water & essential medicines ready.
6. Stay updated through official announcements from the District Administration, DDMA, and Silchar Municipal Corporation.
7. Keep mobile phones charges and stay connected with local administration and emergency services.
8. In case of emergency, contact the District Control Room or Revenue Circle Office/BDO Office/Police Station for assistance.

The District Administration is closely monitoring the situation, and all relevant departments have been instructed to remain on high alert and take proactive measures to manage any emerging flood-like scenario.

The public is requested to avoid spreading rumors or panic, and rely only on official sources for verified information.


