

MINUTES OF THE REVIEW MEETING ON CURRENT FLOOD SITUATION TAKEN BY THE INTER-MINISTERIAL CENTRAL TEAM HELD ON 19TH JULY, 2024 AT 9 AM IN THE NEW CONFERENCE HALL OF THE OFFICE OF THE DISTRICT COMMISSIONER, CACHAR, SILCHAR.

Members Present: As per Annexure "A".

The District Commissioner, Cachar, Silchar presided over the meeting. At the outset of the meeting, the D.C., Cachar welcomed all the Inter Ministerial Central Team (IMCT) members Viz. Shri Mihir Kumar Das, IDAS, Joint Secretary, MHA, Govt. of India, Shri Sanjeev Kumar Suman, Superintending Engineer, Ministry of Jal Sakti, Shri Jintu Das, Director Directorate of Jute Development, Dept. of Agriculture & Farmers Welfare, Shri Partha Paul, Under Secretary (PFC-1) Dept. of Expenditure, Ministry of Finance New Delhi. After that CEO, DDMA, Cachar, Shri Yubaraj Borthakur felicitated the IMCT officials. Later, D.P.O, Cachar Shri Shamim Ahmed Laskar presented through Power point presentation regarding the first and second wave of flood in Cachar and explained the responses undertaken from the end of District Administration like opening of relief camps and relief distribution centers, amount of G.R. items distributed so far, etc. He also explained the initiatives taken by different State Govt. Departments like APDCL, PWD Territorial Road Divisions, Animal Husbandry & Veterinary Department, PHE Department, Irrigation, Fishery, IWT, Health Departments, etc.

After that the enquiry, instruction and suggestion made by the IMCT officials, Govt. of India with respect to present flood situation in Cachar District may be summarized pointwise below:

1. The officials from the Inter-Ministerial Central Team (IMCT) has instructed the District Agriculture Officer, Agriculture Dept. to classify the flood affected land in two classes i.e. Irrigated & Non irrigated and submit report accordingly.
2. The Inter-Ministerial Central Team (IMCT) officials instructed the Chief Executive Officer APDCL Department to clarify the damage report properly indicating number of electric pole, wires etc that were damaged.
3. The Inspector of Schools, CDC, Silchar & District Mission Coordinator, SSA, Cachar, Silchar have been instructed to specify the school damage report indicating kinds of damage in specified way and submit report accordingly.
4. The Inter-Ministerial Central Team (IMCT) officials have instructed to submit detailed reports in respect of road damage etc by mentioning length of damage portion along with the chain number etc.
5. The Executive Engineer, PWD Roads has been instructed to provide appropriate data regarding the extent of total damage of the structure of roads.
6. The District Social Welfare Officer, have been instructed to specify the Anganwadi Centres damage report indicating nature of damage in specified way and submit report accordingly.
7. The Joint Director of Health Services, Cachar have been instructed to specify the Public Health Centre damage report indicating nature of damage in specified way and submit report accordingly.

8. The Addl. District Commissioner, PHE, Cachar have been instructed to specify the Jal Jeevan Mission Scheme damage report etc indicating nature of damage in specified way and submit report accordingly.
9. All the state Govt. departments have been instructed to submit the extent of damage in details with proper format and also considering the Govt. norms etc so that Govt. can release necessary fund as per requirement.

Further, Shri Mihir Kumar, IDAS, Joint Secretary, MHA, Govt. of India appreciated the proactive action/efforts undertaken by the District Administration to mitigate the Flood Situation in the District.


After that, DC Cachar thanked all the members of Inter-Ministerial Central Team (IMCT) for sharing their valuable suggestions and the meeting was ended from vote of thanks of the chair.
