No. CRK.21/2022/39 : Whereas, District Commissioner, Cachar as floated an advertisement vide No. CRK. 21/2022/14 dtd. 24/02/2023 for filling up 63(Sixty three) Nos. vacant posts of Patwari in the amalgamated establishment of the District Commissioner, Cachar in partial modification to earlier Advertisement No. CRK. 21/2022/8 dated 15/02/2023.

Whereas, in view of the interim order passed by the Hon'ble Gauhati High Court dated 28/02/2023 in WP (C) No. 1106/2023 (Abhishek Roy-Vs- The State of Assam & 2 Ors.) , the recruitment process has been stayed.

Whereas, The Assam Land Records Subordinate Service Rules,2023 came into force with effect from 01.04.2023, the Director of Land Records & Surveys etc., Assam was designated as Appointing Authority for the post of Land Record Assistant(formerly Mandal/Amin/Patwari).

Now, therefore, in pursuance of formulation of the Assam Land Records Subordinate Service Rules,2023 with effect from 01.04.2023 and in view of letters vide No. DLR-11013(11)/1/2023/151 dated 15-05-2026 and No. DLR-11013(11)/1/2023/154 dated 21-05-2026 communicated by Addl. Director of Land Records, Assam , the Advertisement issued vide No. CRK. 21/2022/8 dated 15/02/2023 and No.CRK. 21/2022/14 dated 24/02/2023 for recruitment to the post of Patwari(presently re-designated as Land Record Assistant) in the amalgamated establishment of the District Commissioner, Cachar hereby stand cancelled.

This order shall come into force with immediate effect.


